Whereas this court vide record of Proceedings dated 31.10.2005 inter alia advised respondent to calculate reservation for persons with disabilities in the posts of Principal and Assistant Director against the vacancies filled since 1996 and to distribute the reserved vacancies equally between two identified categories of disabilities i.e. persons with locomotors disability and visually impairment. The respondent was further advised either to issue corrigendum inviting applications from visually impaired persons or to keep the required number of vacancies unfilled. Another communication dated 09-12-2005 addressed to Commissioner Navodaya Vidyalaya Samiti, HQ, New Delhi with copy to the respondent was sent for submitting the information by 20-12-2005 and to issue instructions to all the Regional Offices to indicate reservation of vacancies in recruitment an seats in admission for persons with disabilities in all their advertisements.

Whereas no action taken report has been received, Shri M.K. Rastogi, chairperson, Advocacy & Employment Committee, All India Confederation of the Blind, Delhi vide his applications dated 31-12-2005 and 12-01-2006 has informed that the written examination for the posts is going to be held on 22-01-2006.

In the light of the above, the respondent is directed to either submit the copy of the corrigendum as per the directions of Record of Proceedings, or intimate the number of vacancies being kept unfilled for both categories of disabilities and the basics thereof failing which the examination for the said post reported to be held on 22-01-2006 be withheld.
