UPON hearing the counsel the Court made the following  
O R D E R

W.P.(C)No.116/1998 :

1. It is pointed out by learned counsel for the applicant(s) that the States of Haryana, Karnataka, Uttar Pradesh & Uttarakhand and the Union Territory of Lakshadweep have yet to report compliance of the Rights of Persons with Disabilities Act, 2016 (for short, Act of 2016). Other states have also not filed affidavit, as ordered by this Court.
2. It is further submitted by learned counsel that compliance of the Act of 2016 has not yet been started by various State Governments.
3. In the circumstances, we grant time to the States of Haryana, Karnataka, Uttar Pradesh & Uttarakhand and Union Territory of Lakshadweep to report compliance of the Act of 2016. Let efforts be made by the Governments of aforesaid States and the Union Territory and also other State Governments/Union Territories to start compliance of the provisions of the Act of 2016, within a period of three months from today.
