## <u>ORDER</u> 09.05.07

On going through the record, we find that the petitioner has already approached the Railway Board by sending a legal notice on 7.3.2007. In the said notice similar statements as in the present writ petition have been made. The representation was sent on 7.3.2007 which must have received by the Railway Board. In been these circumstances, it would be appropriate for the Railway board to consider the said pleas and contentions raised by the petitioner.

Counsel appearing for the Railways also states that Railway is ready and willing to consider the aforesaid contentions and pass appropriate orders and take steps in accordance with law, if called for. She has fairly stated that the present litigation is not adversarial in nature and the Railways consider that it is their duty and obligation to help and provide job opportunities to challenged persons as per law. We are also of the considered opinion that the contentions raised could be appropriately looked into and considered by the Railway Board. If the petitioner is still aggrieved, he has remedy open to him to approach the Commissioner Disabilities and other authorities under the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full participation) Act-1995.

Learned Counsel appearing for the petitioner seeks permission to withdraw the petition. We give permission.

The writ petition stands dismissed as withdrawn with the aforesaid observations. Representation submitted by the petitioner shall be considered and action, if any called for, should be taken expeditiously.
